1 OVERVIEW

This *Linktropy Mini² Hardware Guide* describes the physical hardware of the Linktropy Mini² WAN Emulator. The companion *User's Guide* describes the installation, configuration, and operation of the Linktropy Mini² WAN emulation functionality. A separate *Quick Start Guide* provides a walk-through for first time configuration.



The Linktropy Mini² contains no user serviceable parts. Opening the chassis voids the warranty. If you believe your unit is not functioning properly, see Section 5 for information on obtaining support.

This guide is for Linktropy Mini² hardware revision –P3.

3 FRONT AND REAR PANELS


3.1 Front Panel



The front panel of the Linktropy Mini² contains:

Power LED: Lit green when the unit is powered on. Unlit when power is off.

3.2 Rear Panel



The rear panel of the Linktropy Mini² contains:

CONSOLE: Console interface using RS-232 with a DB-9 connector.

LAN A: 10/100baseT Ethernet interface with a standard RJ-45 plug. Connects to the network segment functioning as LAN A in network emulations.


LAN B: 10/100baseT Ethernet interface with a standard RJ-45 plug. Connects to the network segment functioning as LAN B in network emulations.

MGMT: 10/100baseT Ethernet interface with a standard RJ-45 plug for browser-based management of the unit over the network.

Power input: Standard DC power jack with 2.1 mm center pin. The center pin is positive and the sleeve is ground. 7-20V DC power.

4 CONSOLE INTERFACE

Console access to the Linktropy Mini² is through the RS-232 interface on the rear panel labeled "CONSOLE." A DB-9 cable is included with the unit to connect the device to a standard PC serial port. The pin-out for the DB-9 connector is shown below:

To connect to the console, use a terminal or a computer running terminal emulation software, and set the following parameters:

- 9600 baud
- 8 data bits
- No parity
- 1 stop bit
- Disable flow control
